



It appears the majority of committee members prefer Plan A. Susan claims I have divided the group, and "turned everything into a YOU vs. US." This isn't accurate. Doesn't have to be a You vs. US. Other committee members are interested in exploring options. Susan initially expressed interest as well. I developed Plan B in consideration of her thoughts and suggestions to do more research.

Coming in open-minded, respectful and with aloha, I found the group pre-biased to past precedent. The group bullied, intimidated, shunned, slandered and libeled, even sexually harassed — simply because I advocate a Plan B. There are some criticisms about the website, which is part of Plan B. The committee had no website. I filled a gap. Members are free to submit content and ideas, and have submitted content and ideas. Not sure the tension here.

Members demand to lock in amenities or facilities related to Plan A, which constrains other options. All I have requested is to develop Proof of Concepts for both plans. To move Plan B Proof of Concept forward, I need updated classmate information. We can't provide one team information while denying the other. Have made this request many times. Do not wish to see clouds develop over our deliberations.

With respect, please have members provide to me the most recent classmate roster so I can program this information into the Plan B system. Plan A is a relatively simple data management project. Plan B requires far more sophisticated information management. Delay receiving this information obstructs development of Plan B and possibly injures our classmates.
