RE: Officer Alves 108

Complaint

- 1. Discrimination by Officer Alves based on Sex of Male, Scott Goold ("Goold"), in reference to alleged complaint reported by Female, Ann Jesse Driever ("Driever").
- 2. Negligent investigation of factual evidence by Officer Alves in reference to alleged complaint reported by Ann Jesse Driever.
- 3. Incompetent application of "media violation" statute by Officer Alves in reference to alleged complaint reported by Ann Jesse Driever.

Goold is a resident of State of Hawai'i. Goold graduated from Highland High School; elected class president 1975; and coincidentally, was teammate to current mayor of Chubbuck, Kevin England. They were successful members of HHS outstanding basketball team.

Goold is familiar with laws in Hawai'i, in particular, HRS § 711-1106: Criminal Harassment:

- (1) A person commits the offense of harassment if, with intent to harass, annoy, or alarm any other person, that person:
 - (b) Insults, <u>taunts</u>, or challenges another person in a manner likely to provoke an immediate violent response or that would <u>cause the other person to reasonably believe</u> that the actor intends to cause bodily injury to the recipient or another or <u>damage to the property</u> <u>of the recipient or another</u>;
 - (c) Repeatedly makes telephone calls, facsimile transmissions, or any form of electronic communication as defined in section 711-1111(2), including electronic mail transmissions, without purpose of legitimate communication;

On May 16, 2024, about 3:30 PM HST, Officer Alves informed Goold that Driever reported Goold violating "media" statutes in Idaho. Conversation occurred on speaker phone in Goold residence with Goold's wife listening. Officer Alves claimed Goold was in violation of "media" statutes. Any further attempt by Goold to contact Driever would result in a criminal citation.

Goold informed Officer Alves that he was HHS Class President 1975; that Driever had stolen some \$1500 [\$1525.98] in Class of 1975 funds. Officer Alves informed Goold this concern was a civil matter and not relevant. Officer Alves directed Goold not to contact Driever, any Driever relatives or face criminal citation. Goold claimed Officer Alves had no jurisdiction to threaten him.

Goold has NO "personal" or "social" reason to contact Driever or Driever relatives. Goold contacted Driever and Driever relatives SOLELY for "purpose of legitimate communication."

Driever refuses to transfer \$1500 in Class of 1975 funds, which Goold has sought since May 23, 2024. These funds are not property of Goold, but entire HHS class of some 440+ students. Goold chairs Reunion 50 committee, as members prepare for 50th celebration summer 2025. Driever refuses to return class funds. Driever "taunts" and bullies Goold, "HaHa ... will not release funds."

Goold "<u>reasonably believes</u>" Driever may cause "<u>damage to the property of the recipient or another</u>." Not only 440+ HHS students, but spouses, children and grandchildren are harmed — upwards of 1,000 individuals. The 50th reunion is a priceless memory. Driever's actions are malicious, abusive, and needlessly cause frustration in what should be a pleasant endeavor.

Driever allegedly claimed Goold was harassing her and family. Had Officer Alves acted professionally, competently, and in accordance with equal protection guarantees under Title IX, Civil Rights Act of 1964, and the Fourteen Amendment, Goold believes female Officer Alves would not have threatened Goold, a male, with criminal citation, but instead, instructed Driever, a female, to return stolen HHS Class of 1975 funds and cease her abusive bullying behavior.

Goold claims Driever made (1) a false report about Goold's alleged behavior to the Chubbuck Police Department ("CPD"); and (2) Driever is criminally harassing and abusing Goold by "taunting" Goold refusing to return stolen HHS Class of 1975 funds, and (3) Driever is "<u>without purpose of legitimate communication</u>" to complain to CPD or "taunt" and abusively bully Goold.

Driever claims Goold displayed pictures of Driever relatives. Goold accidentally connected with Nicole Driever Nelson ("Nelson") when seeking assistance to convince Driever to return stolen funds. Goold has no "personal" or "social" connection to Nelson.

Nelson informed Goold she was daughter of Driever, and advocate for DV victims. Goold requested Nelson to intervene and convince Driever to return the stolen funds. Nelson stated to Goold, "I am also a mental health professional ... My mother is a kind, honest, and hard-working woman. I will always back her up. ALWAYS!"

Goold publicly criticized Nelson for lack of professional ethicals and hypocrisy. Nelson expects clients and victims to behave professionally — setting aside personal feelings and relationships. Nelson however "will always back [Driever, her mother] up. ALWAYS!" Goold has a reasonable "purpose of legitimate communication" to provide commentary about Nelson's position.

Goold alleges female Officer Alves accepted the one-sided report of female Driever, concluding male Goold was at fault, discriminating by sex, negligently failing to investigate facts, and incompetently applying the "media violation" statute.

Goold has a reasonable "purpose of legitimate communication" to attempt to convince Driever to return stolen HHS Class of 1975 funds. Time is of the essence. Driever may spend the funds. Lack of funding obstructs progress on the priceless Reunion 50 event for upwards of 1,000 individuals.

Goold submitted an official complaint about Driever's theft of Class of 1975 funds to HHS Principal, Dr. Brad Wallace, May 24, 2024.

Goold filed an official complaint about Driever's theft of Class of 1975 funds with Pocatello Police Department, May 31, 2024.

HHS Class of 1975 committee is not a legal company or organization. Classmate groups follow years of tradition, but without formal structure. Common civil avenues of conflict resolution are frustrated. Officials are hesitant to become involved.

Female Officer Alves could have served to mediate this difficult conflict by treating male Goold equally to female Driever, competently investigating facts, and properly applying the "media violation" statute. Driever simply needs to return HHS Class of 1975 funds and this unpleasant behavior ends. Driever is "taunting" Goold, inciting tension and hostility, and needlessly involving Nelson and relatives.

Driever is the bad faith actor in this mater. Female Driever however contacted CPD for assistance. Female Officer Alves was readily motivated to assist her sister in a campaign to criminally harass, taunt and bully Goold.

FACTS IN THIS MATTER

No recent verbal communications between Goold and Driever. Goold sought communication with Driever to end conflict. In sarcastic text, Sunday, June 9, 2024, Driever responded to Goold's multiple requests to talk, "Nothing to say."

Goold discussions with Nelson are recorded in Facebook messenger application. Goold suggests CPD request the thread of communication.

Goold discussion with Driever are recorded in "Highland reunion" group committee text communication. Goold and Driever have some interpersonal discussion in their individual text communication. Goold suggests CPD request the threads of communication.

Goold maintains HHS Class of 1975 website at: **www . HHSRams1975 . com**. Goold requests CPD review history of activity, behavior and communication archived in this Internet portal.

- It is not disputed Driever served as committee chair for the initial 50th reunion planning group.
- It is not disputed Driever resigned as committee chair May 22, 2024.
- It is not disputed HHS Class President Goold accepted resignations May 23, 2024, and assumed Reunion 50 chair.
- It is not disputed HHS Class of 1975 Treasurer, Roy Allen, met with Driever on about May 24, 2024, and texted to Goold next day:

"Hi Scott, I met with [Driever] yesterday and asked her to forward the class funds to you so that you can carry on with your efforts towards the class reunion. She said that she would and you should receive those funds soon. Roy"

As of June 16, 2024, Driever refuses to release the stolen funds. Conflict ends when Driever complies with the directive of HHS Class of 1975 Treasurer Roy Allen.
