Aloha Ann, Jeff and Susan ~

Clearly we're at impasse at this time without a clear path to resolution. You noted your frustration working with me. The group stepped down Wednesday, May 22nd. Your cooperation ends our painful dispute. We can move forward for the class, and hopefully begin work to heal feelings and restore good faith between us.
