On May 31, 2024, you were notified of using *InfoImagination* copyrighted materials (attached). This material was posted unlawfully to Facebook Page, May 27, 2024 (screenshot 5.31.24). You were notified *InfoImagination* charges [\$100.00/day] for unauthorized use of *InfoImagination* intellectual property in violation of Copyright Law of the United States (Title 17).

On June 1, 2024, you responded by text, “I’m done! When do you want the Facebook page?” You were instructed professionally, “Good morning. You can transfer login credentials to me here using text. We can end this matter. Thank you!”

You however did not transfer login credentials or remove *InfoImagination* copyrighted materials. Instead, you were defiant, unprofessional and malicious. You doubled-down continuing to use *InfoImagination* copyrighted materials, refused to transfer login credentials and blocked Scott Goold, member of Class of 1975, from “Class of 75” Facebook Page — denying Scott Goold access to classmate connections and communication. You forced Scott Goold to file complaints with authorities, including Facebook Copyright Infringement Legal Department.

On June 11, 2024, *InfoImagination* reviewed “Class of 75” Facebook Page. *InfoImagination* copyrighted materials had been removed. Scott Goold informed former members of the reunion committee. As you did not notify *InfoImagination* of the date these copyrighted materials were removed, *InfoImagination* assumes June 10, 2024. Please remit payment within 30 days.

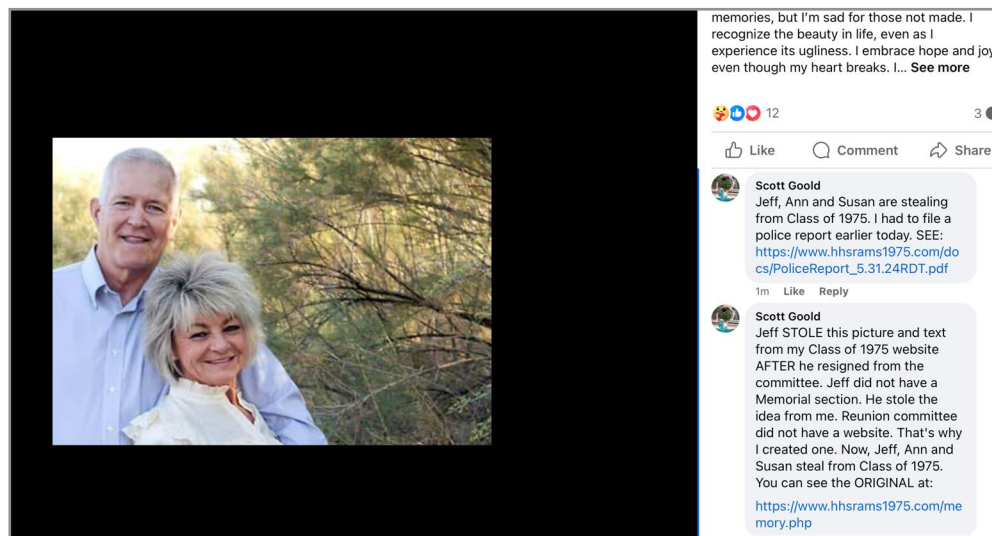
**RE: Jeff Waldron steals Intellectual Property from Scott Goold, Class of 1975**

Scott Goold created graphical imagery and authored textual content pursuant to Copyright Law of the United States (Title 17), and posted this copyrighted intellectual property to the HHSRams1975 website, a product of *InfoImagination* © 2008-2024. Jeff Waldron stole this property and posted the material unlawfully to his Facebook project, May 27, 2024 (screenshot 5.31.24). Jeff refuses to transfer the Class of 1975 Facebook page to the ad hoc Reunion 50 committee. Class President filed a complaint with the Pocatello Police Department.



When first connecting with the committee, Scott Goold discovered they had no website. Scott designed and created a full-function database driven application, including a backend administrative portal.

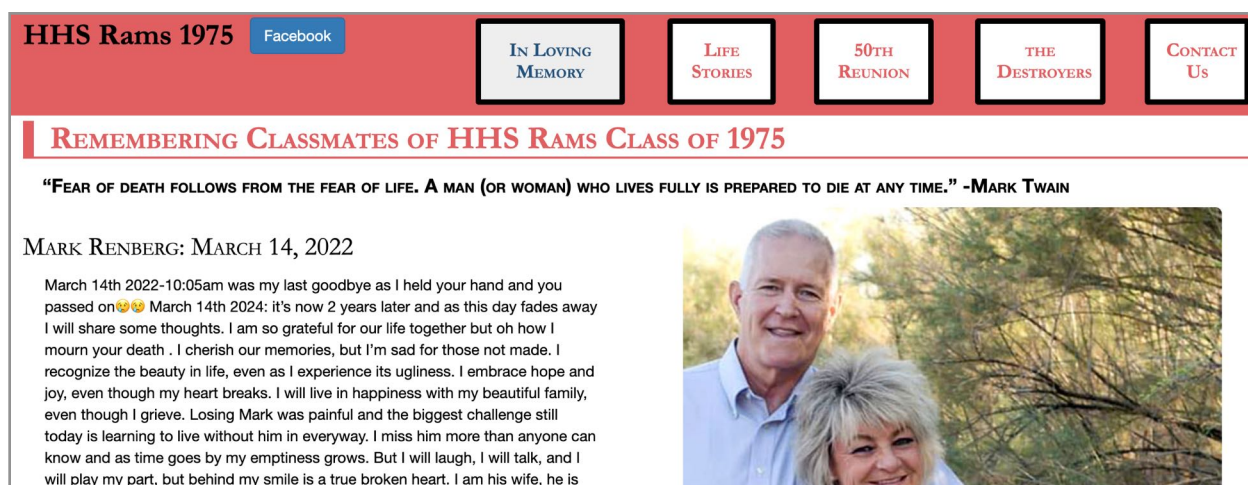


Scott Goold created a section, In Loving Memory, to honor classmates who have passed. The committee did not have such a feature included in the class Facebook page. Jeff Waldron not only stole the intellectual property of *InfoImagination*, but copied Scott Goold's creative design.

Jeff Waldron resigned from the planning committee, Wednesday, May 22, 2024. Now refuses to pass the Class of 1975 Facebook login credentials to Class President, and continues to post unapproved commentary to the class page.

Due to fraudulent behavior and tortious interference by Jeff Waldron, Ann Driever and Susan Mattivi-Gierga for failing to transfer Class of 1975 funds and intellectual property to ad hoc Reunion 50 committee, Scott Goold filed a police report today:
